Independent Museum Professionals

Member-led organization designed to build community and foster collaboration among IMPs who represent varied disciplines, levels of professional experience, and diverse perspectives.

Small Business Development Center(s)

Free, federally-funded, with local branches across the US. SBDC provide counseling and training to small businesses. "Great for figuring out the steps for launching your business and for locating local lawyers, accountants, insurance brokers, etc. who are willing to work with freelancers and small start-ups."

SCORE

SCORE is the mentorship arm of the U.S. <u>Small Business Administration</u>. A business mentorship program. "I've had mixed success with SCORE. Initially I was told that I needed to be in business for 2 or 3 years before they could offer much help. Since then, they have been far more helpful. You get paired up with a mentor and like all mentors, sometimes you have to try a few before you get one that you work well with."

Freelancers Union

NYC-based non-profit that supports and advocates for freelancers (across the U.S.) Does a lot of advocacy work, promotes passage of the <u>Freelance Isn't Free Act</u> in cities and states across the U.S. Free to join the mailing list and to attend webinars on crafting contracts, promotion, etc. *Lots* of <u>resources</u> around legal issues and contracts, taxes, insurance, etc. There is also a <u>Black Freelancers Directory</u>. Note that webinars that are recorded tend to be available for only a month after they were live.

Closed Facebook group of people who provide consulting services to nonprofits. "I've found this a very helpful group, especially around client management. Read the group rules!! (e.g. zero self-promotion with a few strict exceptions; no discussion of actual fees, etc.)"

Closed facebook group related to Freelancing Females.com. "Unlike the (gender-inclusive) Nonprofit Consultants Virtual group, this group does seem to allow discussion of actual fees in discussion of pricing strategies. (Note that unlike Freelancer's Union, <u>Freelancing Females</u> itself does not appear to be a nonprofit, though membership isn't required to join the FB group."

They can only provide computer support if they can connect to your computer. So when I had wifi issues, I had to get an ethernet cable to connect. They refused to provide phone-only support."
